The Wildwood – Wildwood Highlands Community Well is dead, and has been declared to be an unlikely candidate for resurrection. The well fund has been dissolved and contributions returned to WHLA members. The WHLA BoD will make the issue of a new well (or ?) one of high priority in the next few months.

ROADS

Roads within and leading to Wildwood Highlands are the major concern of (and major reason for existence of) the WHLA. VP David Brown is the chair of the BoD roads committee. David has been extremely active since 25 May and has prepared this report:

We had a couple of rain showers in June that allowed us to do roadwork without bone dry conditions. Summers Reed and crew did the work, bringing four loads of gravel on Western View Drive, 2 loads on Rock Spring Circle and one on Agua Fria near the western end. This was in addition to 3 culverts placed to divert water from soaking the roads and washing away gravel and road base. We can use many more culverts.

Agua Fria Hill in Wildwood has always been a problem because it washboards so easily. Part of the problem is that the gravel is so deep and loose. We brought in two loads of crusher fines and pulled some of the gravel into this in hopes of binding the gravel more and preventing it from wash-boarding as easily. Your help can also be of value if we can remember to keep a light foot on the accelerator on the hill.

This spring we gave more attention to grading the secondary roads. Some roads have not seen a grader in five years. Unfortunately there are areas where there is just not enough dirt to grade and these areas we couldn't really do a thing. A grader can do nothing with solid rock. We want all roads to be better and we are interested in your ideas and suggestions.

We are also interested in your help as there are a number of projects that need to be done that really require man hours more than heavy equipment and volunteers are being sought. If spending a morning with shovel in hand or carrying rock sounds like fun, contact David Brown or any other board member.

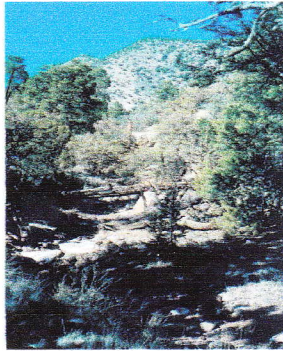
POLICY ON MEMBER COMMUNICATIONS
