2008 ANNUAL MEETING

The 2008 annual meeting of the WHLA will be held at the Datil Volunteer Fire Dept. firehouse in Datil on 17 May 2008, at 10 AM MDT. The formal notice, agenda, list of BoD candidates, ballots, and other material will be mailed to all members in early April. Please see the material below regarding BoD elections. Please also recall that our new bylaws incorporate detailed procedures for consideration of amendments to same. The bylaws are on the web site. For convenience Article 7 is repeated here:

Article 7 – Amendments

Section 7.1 – Proposal: An amendment may be proposed by:

- a resolution of the Board of Directors, approved by a majority of the Board, or
- members in good standing having five or more of the votes entitled to be cast at the annual meeting.

A proposed amendment must be filed with the Secretary of the Association not less than forty (40) days before the date of the annual meeting. The proposers may provide a statement, of not more than 100 words, in support of the proposed amendment, for inclusion with the Notice of Meeting. The Board of Directors may also provide a statement, of not more than 100 words, for or against the proposed amendment, for inclusion with the Notice of Meeting. The board reserves the right to edit material deemed patently offensive.

Section 7.2 - Approval: To be approved at an annual meeting, or at a special meeting, a proposed amendment must receive an affirmative vote of members in good standing having two thirds or more of the votes entitled to be cast at such meeting.

Amendments must be received by 7 April for consideration this year.

BoD CANDIDATES NEEDED

There will be two vacancies on the WHLA BoD this year. If you have an interest in serving on the BoD, please remember that written nominations are due NLT 40 days prior to the annual meeting (that date this year is 7 April! Hurry!), and must be signed

and dated by at least two members in good standing having two or more votes (bylaws Section 4.4 excerpt below). Send the nominating papers to the Secretary, WHLA, POB 87, Datil, NM 87821-0087.

Section 4.4. Nomination (excerpt)

A member in good standing may be nominated for the position of Director by the submission of nomination papers to the Secretary of the Association, not less than forty (40) days before the date of the annual meeting. The nomination papers shall be signed and dated by the nominee, and signed and dated by members in good standing having two or more of the votes entitled to be cast at the annual meeting.
